The Cayman Islands' legal system is based on English common law, locally enacted statutes and Orders-in-Council. Local principal statutes (laws) are passed by the Legislative Assembly and assented to by the Governor. The Cayman Foundation Company (the "Foundation Company") is governed by the Companies Law (2020 Revision) (the "Law") of the Cayman Islands except as specified in The Foundation Companies Law, 2017. The Foundation Company is a not for profit body corporate having separate legal personality and may be established for any lawful purpose including commercial and charitable purposes.
