The fourth step of the fiancé (e) process is a big distinction from marriage cases. After entering the U.S. on a K-1 fiancé (e) visa, the foreign national has 90 days (3 months) in which to marry her U.S. fiancé (e). If the marriage does not occur within the 90 days then the foreign spouse is supposed to depart the U.S.
